From 2000 until May 2007, he served as CEO of Glitnir (formerly Íslandsbanki hf.), a leading Iceland-based financial group and a leading niche player worldwide in seafood/food, sustainable energy (geothermal energy) and offshore supply vessels. Prior to his time at Glitnir, he worked at the Kaupthing Bank from 1991 to 1997, most recently as CEO. In 1997, Mr. Ármannsson was appointed CEO of FBA (The Icelandic Investment Bank), which later merged with Íslandsbanki hf. in 2000. Mr. Ármannsson has a BSc in Computer Engineering and an MBA from IMD in Switzerland.

Mr. Reite, who lives in Aalesund (Ålesund) and Oslo in Norway, was CEO of KredittBanken, a niche bank in Norway, which was purchased in 2004 by the Glitnir Group. Mr. Reite was a member of the executive management board of Glitnir from 2005 until he left Glitnir last fall. He was responsible for growing Glitnir's Nordic operation through the acquisition, integration and development of a number of companies, including BNbank, Glitnir Securities, Glitnir Factoring, Glitnir Property Group (formerly Union Gruppen, Leimdörfer and BSA), Glitnir AB (formerly Fischer Partners) and one of the leading Finnish asset management companies, FIM (now Glitnir Oy). Prior to joining the Glitnir Group, he was a senior executive of Aker, a diversified Norwegian industrial holding company with a focus on energy, maritime and marine-resources industries. At Aker, he held a variety of executive positions overseeing and developing Aker investments within seafood and shipbuilding, including Norway Seafoods and American Seafoods Company (ASC). Mr. Reite has a degree in business administration from Handelshøyskole BI (the Norwegian School of Management).
